

For the year ending December 31, 2017, the Commonwealth of Virginia saw an increase in the number of tracked alternative fuel fleet vehicles by 0.94%. The current percentage of alternative fuel vehicles used in Virginia fleets is 39.73%. All alternative fuel vehicle types except for HEV exhibited

growth in 2017. There was a significant (30.59%) increase in LPG fleet vehicles in 2017. The vehicles reported are in service with private business fleets and local, state and federal government fleets.


