Diesel Emissions Reduction Act (DERA) grants now open - Deadline is March 16

The EPA has announced the availability of \$46 million in DERA grant funds to support projects aimed at reducing

emissions from the nation's existing fleet of older diesel engines. Eligible applicants include regional, state, local or tribal agencies, or port authorities, with jurisdiction over transportation or air quality. Nonprofit organizations may apply if they provide pollution reduction or educational services to diesel fleet owners or have, as their principal purpose, the promotion of transportation or air quality.
