# **US DOE Vehicle Technology Office Funding Opportunities**

The Office of Energy Efficiency and Renewable Energy (EERE) intends to issue, on behalf of the Vehicle Technologies Office, a Funding Opportunity Announcement (FOA) entitled "Fiscal

Year 2023 Vehicle Technologies Office (VTO) Program Wide Funding Opportunity Announcement" (# EE0002892). Building a clean and equitable energy economy and addressing the climate crisis is a top priority of the Administration. This anticipated FOA will advance goals to achieve carbon pollution-free electricity by 2035 and to "deliver an equitable, clean energy future, and put the United States on a path to achieve net-zero emissions, economy-wide, by no later than 2050 to the benefit of all Americans." The Department of Energy is committed to pushing the frontiers of science and engineering, catalyzing clean energy jobs through research, development, demonstration, and deployment, and ensuring environmental justice and inclusion of underserved communities.

## **FTA Low-No and Bus Competitive Grant Programs**



Join FTA this month to learn about a competitive funding **opportunity** for nearly \$1.7 billion that will support state and local efforts to modernize aging transit fleets with low- and no-emission buses, renovate and construct bus facilities, and support workforce development.

Potential applicants to the FY23 <u>Low or No Emission (Low-No) Program</u> and <u>Grants for Buses and Bus Facilities Program</u> are welcome to attend either of the two scheduled webinars. Webinar attendees will learn about program eligibility, evaluation criteria and selection considerations, and the submission process.

The first webinar will be held on February 16, 2023, and will be a general session for all applicants. The second webinar will be on February 28, 2023, and will have a Q&A session focused on questions from rural and tribal applicants.
