America's dependence on petroleum is harmful to our environment, our quality of life, and is not sustainable.

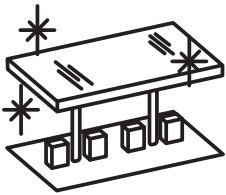
Nearly a third of our nation's energy goes into transportation. **92%** of that comes from petroleum. That is a huge opportunity for us to make a difference.

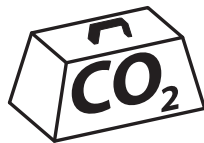
