Virginia NEVI Deployment information sessions



As part of the National Electric Vehicle Infrastructure (NEVI) Formula Program, states are required to update their Deployment Plans on EV infrastructure implementation annually. As part of the Year 2 update, VDOT will be holding two public webinars on **Monday, July 10th**, to discuss electric vehicles, Virginia's Deployment Plan, alternative fuel corridors and upcoming events. 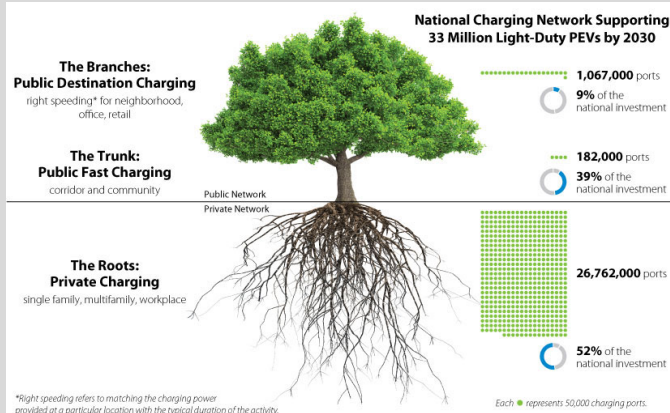

July 31 Green Operator Go-Zero deadline



The Green Operator Program's first round of funding for Go-Zero is open, it provides an incentive of up to \$200,000 for each zero-emission truck purchased and up to \$100,000 for each near zero-emission truck purchased. Like the existing Green Operator program, the expectation is for drayage trucks to provide services to the Port of Virginia facilities. Unlike the current program, scrapping of older diesel-powered trucks during diesel-to-diesel upgrades is not a requirement. An additional incentive of \$25,000 will be available if an older drayage truck is scrapped.
